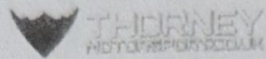

Dear Mr Thorne,

Libel is the act of publishing a written or broadcast statement that is untrue and harms someone's reputation or livelihood. It is considered a civil wrong (tort) and can be the basis of a lawsuit.

So far I can see that you are the only person who, against and in breach of the UKPSA social media policies, broadcasted potentially libelous statements. Therefore, I believe it will be the first case ever, when a claim for libel will be self-inflicted.

As such, I believe that you are in possession of all relevant information in order to sue herself for this tort. Please feel free to send me a copy of your claim, because, as a solicitor, I am extremely curious to see this happening and the way it can develop.

Also, could you please provide me with the name of the Police authority, who has issued your FAC. Based on your previous, and current conduct, I started having great concerns about your mental abilities and I feel they have to be notified about your abilities to adequately react to life events. You show no understanding of the information presented to you as well as no respect for the organisation you are a member of (UKPSA), and by "no respect" I mean no respect for the organisation, its policies and procedures as well as fellow members. Whilst you are still a member of the UKPSA, we have a duty of care to you as well as to other members and so we need to make sure that you are protected, including from yourself. I therefore feel obliged to share my concerns about your mental health issues with relevant authorities hence I will be grateful if you provide me with their details.

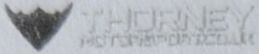
I hope your condition will soon improve and I wish you all the best in your other endeavours.
